Ref: Order No 1968 / R&DM (DM), Dt.15.04.2021 of Office of Special Relief Commissioner, Govt. of Odisha and Order No 2070/ R&DM (DM), Dt.21.04.2021 Madam/Sir,

In view of the pandemic situation arising out of SARS-CoV 2 (COVID) all the training classes under DDU-GKY shall be closed with effect from 22nd April 2021 till further order.

No Project Implementing Agency shall be allowed to start any fresh batch of training until further order.

If the assessment test of the completed training batches has been scheduled to be held within 30th April 2021, the same may be completed wherever possible adhering the Covid guidelines and safety protocols.

All the national heads of PIAs are requested to advise the trainees to leave the campus and vacate the hostels immediately. Further the PIAs are advised to facilitate the smooth transportation of candidates from training center to their place of residence adhering to covid guidelines and safety protocols.
