## ORDER

### **Blacklisting of M/s Everonn Skill Development Limited**

Registered address:- Everonn House, Plot 96-99, Developed Plots Estate Perungudi Chennai

#### **Project Details:**

- Sanction order No. 199 dated 03.06.2014
- Project duration and Target :- One year with target of 2000 candidates
- Total Project cost:- Rs.7, 89, 92,000/-
- MoU with M/s. Everonn Skill Development Limited dated 03.06.2014
- Total amount released (1<sup>st</sup> installment):- Rs.1,49,48,000/- on 29.11.2014 vide Letter No.736
- Proceedings of the meeting held on 19.02.2016 with direction to close all the training centers by Mar 2016 and settle the accounts as PIA showed it's inability to continue the training.
- Pre-closure notice issued vide letter No.37 dated 09.01.2017
- Recovery letter issued vide letter No. 800 dated 31.03.2019
- Legal notice issued on 11.01.2020

Whereas, M/s. Everonn Skill Development Limited had been sanctioned a project under DDU-GKY (Erstwhile Aajeevika Skills) for imparting placement linked training to 2000 rural youth of Odisha vide sanction letter No. 199 dated 03.06.2014.

In pursuance of the said sanction order, an MOU was signed on 03.06.2014 between ORMAS and the said Project Implementing Agency according to which PIA had to impart placement linked training to 2000 candidates within a period of 1 year. Total contract value for implementation of the project was Rs.7, 89,92,000/- ( Rupees Seven Crore eighty nine lakh ninety two thousand).

As per the sanction order, M/s. Everonn Skill Development Limited received 25% advance amounting to Rs. Rs.1,49,48,000/- (Rupees One Crore forty nine lakh forty eight thousand) only on 29.11.2014 out of total project cost Rs.7, 89, 92,000/-(Rupees Seven Crore eighty nine lakh ninety two thousand) only.

The agency failed to perform as per Perspective Project Work Schedule (PPWS) submitted by it. In the review meeting held on 19.02.2016, PIA showed it's inability to continue the training for which it was decided & directed to close the training centers by Mar 2016 and settle the accounts.

The PIA delayed in submitting the training & placement documents for which a pre-closure notice was issued vide letter No.37 dated 09.01.2017 directing to furnish the necessary (Physical & Financial) documents for final settlement within 30 days from the date of issue

of the letter. However, PIA submitted trained & placed documents of some of the candidates but did not submit the financial documents for settlement of accounts. Though it was asked several times to submit the financial documents but PIA did not respond till date.

A recovery letter was issued vide letter No.800 dated 31.03.2019 to refund the entire advance amount of Rs.1,49,48,000/- (Rupees One Crore forty nine lakh forty eight thousand) only with interest @ 10% per annum from the date of release (as per notification no 3/2014 dated 3<sup>rd</sup> February 2014 of MoRD). But PIA did not like to respond the letter.

Not finding any response from the agency, a legal notice was issued to the PIA on 11.01.2020 through the Legal Consultant to refund Rs.2,21,08,092/- (Rupees Two crore twenty one lakh eight thousand ninety two) only inclusive of 10% interest within 10 days of receiving the notice. Further, it was requested to PIA by the Legal Consultant to inform him within 7 days of receiving the notice indicating the steps the PIA was going to take for refunding the amount. But the notice was returned back due to addresses had left the premises.

Several opportunities were given to the agency for closure of the project. But PIA did not like to respond for refund of dues and closure of the project.

*Under the circumstances stated above **M/s. Everonn Skill Development Limited**, Head Office at Everonn House, 96-99 Industrial Estate, Perungudi, Chennai, Tamilnadu -600096 bearing DDU-GKY PRN (Permanent Registration Number) TN2013CR1155 is being **blacklisted** with immediate effect in the State of Odisha till further Order.*
