### Blacklisting of M/s Surya Wires Private Limited

- Project duration and Target: Training target of 1000 with placement target of 700 candidates in one year.
- c. Total Project cost:- Rs.11,63,20,280/-

Whereas M/s. Surya Wires Pvt. Ltd. (Project Implementing Agency) had been sanctioned a project under DDU-GKY for imparting placement linked training to rural youth of Odisha vide sanction letter 184 dated 08/02/2018.

In pursuance of the said sanction order, an MOU was signed on 07/02/2018 between ORMAS and the said Project Implementing Agency according to which PIA had to impart placement linked training to 1000 candidates within a period of 1 year. Total project of for implementation of the project was Rs.11,63,20,280/-

As per the release order, M/s Surya Wires Pvt. Ltd received 25% advance amounting to Rs. 2,89,75,070/- on dated 19/09/2018 as the 1<sup>st</sup> installment fund out of total project cost. The agency neither completed any training nor placement of any candidate since the sanction of DDU-GKY project adhering to the training and placement protocols of DDU-GKY scheme. Hence, show cause letter has been issued for pre-closure on 11/04/2019.

The agency did not complete any training & placement though agreed in the meeting on dated 15<sup>th</sup> April 2019 to resume the training.

Hence, Performance guarantee (in shape of Bank Guarantee) submitted by the agency has been invoked and recovery notice for settlement of account has been issued to the
