## ORDER

### **Blacklisting of M/s. Sahithi Systems Pvt.Ltd**

Corp Office:- 103,7-1-455/2 &3-8, Swathi Manors, Adj Lane to SwathiAnukar Building,  
Huda Maitrivanam Road, Ameerpet, Hyderabad-500016

#### **Project Details:**

- Sanction Order No.475, Date:- 13.08.2014 with total project cost of Rs.2,12,18,000/-
- Project Duration and Target:-Project period one year with target of 500 candidates
- MoU between ORMAS & M/s.Sahithi Systems Pvt. Ltd signed on 13.08.2014
- Total amount released (1st installment):- Rs.42,54,500/- on 13.01.2015 vide Letter No.944.
- Revised Target:- Revised to 444 candidates vide letter No.506 dated 24.04.2017
- Revised Project Cost:- Revised to Rs.2,11,96,826/- vide letter No.506 dated 24.04.2017
- Pre-closure notice was issued vide letter no.578 dated 19.02.2020
- Notice issued vide letter No.776 dated 07.03.2020 for amicable settlement of dispute.
- Notice issued vide letter No.1667 dated 30.06.2020 for recovery of fund.

Whereas M/s. Sahithi Systems Pvt. Ltd had been sanctioned a project under DDU-GKY (Erstwhile Aajeevika Skills) for imparting placement linked training to rural youth of Odisha vide sanction letter No. 475 dated 13.08.2014.

In pursuance of the said sanction order, the MOU was signed on 13.08.2015 between ORMAS and the said Project Implementing Agency according to which PIA had to impart placement linked training to 500 candidates (revised to 444 candidates) within a period of 1 year. Total contract value for implementation of the project was Rs.2,12,18,000/-(Rupees two crore twelve lakh eighteen thousand) only and it was revised to Rs.2,11,96,826/-(Rupees two crore eleven lakh ninety six thousand eight hundred twenty six) only as per MoRD Notification No.25/2016.

As per the sanction order M/s. Sahithi Systems Pvt. Ltd received an advance amounting to Rs.42,54,500/-(Rupees forty two lakh fifty four thousand five hundred ) only on 13.01.2015 vide Letter No.944.

However, the PIA had submitted records of training and placement of candidates for closure of project and settlement of accounts. But after desk verification it was found that documents submitted by the PIA were not as per SOP/guidelines of DDU-GKY. Hence documents were not considered as valid.

Pre-closure notice was issued vide letter no.578 dated 19.02.2020 with a request to refund Rs.64,16,718/- (Rupees sixty four lakh sixteen thousand seven hundred eighteen) only inclusive of 10% interest per annum from the date of release by 29.02.2020, failing which it will be recovered as per the provisions of MoU. Subsequently another notice was issued vide letter No.776 dated 07.03.2020 for amicable settlement of dispute and directed the PIA to present at ORMAS Head Quarter on 12.03.2020 to redress the dispute. National Head of the PIA appeared before the authority on 12.03.2020 and he was advised to refund the advance amount with interest of 10% from the date of release within 15 days. But PIA did not refund any amount.

Further, another notice for refund of above amount was issued vide letter No.1667 dated 30.06.2020 but it was returned back.

Several opportunities were given to the agency for closure of the project. But PIA did not like to respond for refund of dues and closure of the project.

Under the circumstances stated above M/s. Sahithi Systems Pvt. Ltd, Corp Office:- 103,7-1-455/2 &3-8, Swathi Manors, Adj Lane to SwathiAnukar Building, Huda Maitrivanam Road, Ameerpet, Hyderabad-500016bearing DDU-GKY PRN(Permanent Registration Number) AP2013CR1638 is being **blacklisted** with immediate effect in the State of Odisha till further Order.
