Blacklisting of M/s. Skill Education Pvt. Ltd (Erstwhile A4E India Pvt. Ltd.)

Whereas the PIA *Skill Education Private Limited (Erstwhile A4E India Pvt.Ltd.)* has been sanctioned with the first project under DDU-GKY vide sanction order no.385 dated 17.07.2014 withtarget of 750 candidates. The PIA has signed the MoU with ORMAS on 18th July 2014. The 1st installment amounting to Rs.53,24,250/- (Rupees fifty three lakh twenty four thousand two hundred fifty) only was released vide ORMAS letter no.763 dated 29.11.2014 following due procedure which is an advance as per DDU-GKY guidelines.

The PIA had operated training in Odisha and claimed 2nd installment by submitting trained documents of 114 candidates &placed documents of 92 candidates. After due desk verification and physical verification on sample basis it was found that 66 candidates were placed. In accordance to the verification, 2nd installment amounting to Rs. 1,08,02,902/-(Rupees one crore eight lakh two thousand nine hundred two) only was released on 19.01.2016 vide letter no.1226. Further, PIA had submitted trained & placed documents of candidates in various tranches towards release of 3rd installment. During physical verification most of the samples are found not placed for which third instalment to the PIA was not released and it was communicated to PIA vide letter no.678 dated 24.05.2017.PIA was directed to submit all the remaining trained and placed documents for closure of the project. PIA submitted the documents for closure of project but not cooperated in physical verification. Further, PIA has not submitted Q team placement verification report (4th Installment) despite of several intimations. The PIA was intimated vide letter no. 57 dated 08.01.2020 to submit Q team placement verification report (4th Installment) as per SOP on or before 13.01.2020 failing which necessary proceedings will be initiated to recover the amount. But, PIA has not submitted Q team placement verification report till date.

Further, the PIA Skill Education Private Limitedhas been sanctioned with second project under DDU-GKY vide sanction order no.1397 dated 26.02.2016 with target of 1500 candidates. The target was revised to 1029 candidates vide sanction order no.13 dated 04.01.2017 as per MoRD Notification no.25/2016 (revision of cost norms of DDU-GKY programme). The PIA has signed the MoU with ORMAS on 22nd Feb 2016. The 1st installment amounting to Rs.1,05,54,750/- (One crore five lakh fifty four thousand seven hundred fifty) only was released vide ORMAS letter no.1399 dated 26.02.2016 following due procedure which is an advance as per DDU-GKY guidelines.

The PIA had operated training in Odisha and claimed 2nd installment by submitting trained &placed documents of 160 candidates. After due desk verification, following the procedure laid down in the SoP it has been found that 159 candidates were trained and 120 candidates were placed. But during physical verification 8 samples are found as not placed for which 2nd installment was not released.

PIA was directed to submit all the trained and placed documents for orderly closure of the project. PIA had submitted trained and placed documents towards closure of project which were found incomplete and not as per SOP during desk verification. PIA was intimated on 24.05.2021 to comply with the desk verification result within 15 days failing which it will be considered that PIA has nothing to say on the result of desk verification undertaken by ORMAS. But the PIA did not like to respond any of the communication.
