- Project – 1 was sanctioned to the PIA vide sanction order No.54 dated 12.04.2015 for providing training to 530 no of candidates and placement of 398 no of candidates at a cost of Rs.2,54,22,200/-.
 - 1st installment of Rs.58,84,550.00 was released on dated 14.05.2015.
 - 60 trained candidates documents and 51 placed candidates documents submitted for claiming installment – 2.
 - 2nd installment of Rs.1,18,22,196/- was released on 05.09.2017. In total Rs.1,77,06,746/- released to the PIA.
 - As per MPR training of 530 no of candidates and placement of 405 no of candidates has been completed since 2017. As against that you have only submitted 11% trained candidate documents and 9% placed candidate documents in this office.
 - In the letter No.1817 dated 28.08.2018 you have been requested to submit all documents by 10th Sept, 2018 for closure of the project.
 - After lapses 4 years you have not yet submitted documents (Installment – 3 & 4) for closure of the Project. All trained and placed documents may be submitted within 15 days of receipt of this letter.
