

- Project – 2 was sanctioned to the PIA vide sanction order No.1368 dated 09.07.2018 for Training target 300 and Placement target – 210 at a project cost of Rs. 1,95,66,884/-/-.
- The project cost was revised sanction order No.3464 dated 22.12.2020 the training target of 291 and placement target of 204 fixed at a Project cost of Rs. 1,95,54,850 /-
- 1st installment of Rs. 48,60,222/- and 2nd Installment of Rs.42,73,611/- Total Rs.91,33,833/- released to the PIA till date.
- As per MPR PIA has trained 142 no of candidates and placed 104 no of candidates under the project.
- PIA has not yet open the training center after COVID – 19 till date. There is no response of the PIA on opening of the training center and completion of training.
- Very slow progress on the project completion and PIA has not yet completed training of 149 candidates (mostly long term courses) till date.
- The bank guarantee submitted by the PIA was expired from 21.4.2021. But you have not responding to renew the BG after several reminders.
