**Notification 02/2016-DDU-GKY (Odisha)**

**Sub: Appraisal and selection of new proposal under DDU-GKY in the State of Odisha**

The following points will be considered during the appraisal of new proposal and selection of the PIAs for implementing DDU-GKY programme in Odisha, based on decision taken in the meeting chaired by the Secretary-cum-Commissioner on 3<sup>rd</sup> August 2016 at Conference hall of Secretariat, PR Department, Odisha.

The following are the requisites conditions for the eligibility of the PIAs to get project in Odisha under DDU-GKY with immediate effect of this notification.

1. The PIA has annual turnover of Rs. 1.00 Crores in last three years each.
2. Category A & B PIAs are only eligible to apply for DDU-GKY project in Odisha
3. As stated by MoRD in Notification 39/2016, dated 11<sup>th</sup> August, 2016, 3% of the beneficiaries as target allocated shall be persons with disabilities and minimum of 30% of the target approved shall be project with duration equal to or more than 1152 hours will be applicable for Odisha State as well.


Proposal will be considered for appraisal and disposal on the basis of the priorities as mentioned below:

**Proposal – Priorities**

- Foreign placements (500 or more candidates, salary of US\$ 500 per month)
- Champion Employers (10,000 jobs in 2 years with assured career progression)
- Captive Employment (500+ jobs)
- Industrial Internship - 1 year with 75% placement (500 or more candidates, salary Rs.10,000 per month)
- Long term Courses more than 1 year long (over 100 candidates)
- Educational institute (CGPA = 3.5 or more) or Community College (received funding from UGC / AICTE)
- PIA who has completed 3 SGSY special projects/ DDU-GKY projects in last five years
- PIA having skilled 20,000 candidates with 75% placement in last five years
- Foreign placements (200 – 499 candidates, salary of US\$ 500 per month)
- Captive Employment (200-499 jobs)
