**Terms of Reference for Food Stalls During National Level Pallishree Mela-2016**

**A. Background:**

Odisha Rural Development and Marketing Society (ORMAS) was constituted in the year 1991 under Societies Registration Act, 1860 as an autonomous body under Panchayati Raj Department, Government of Odisha. ORMAS works in the field of Rural development & rural livelihood. It provides training, technology & marketing support to the rural poor. In the long run enhancing the quality of life of the rural producers. The district units of ORMAS are known as District Supply & Marketing Society (DSMS). These units are functioning with the basic objective to help rural poor to make a better living by enabling them to improve their production, processing and marketing. DSMS PURI also acts as a facilitating agency for implementation & monitoring of rural livelihoods programmes for the rural producers in the district.

CAR Festival is all about transformation of Puri temple, the deities of Lord Jagannath, Balabhadra, Goddess Subhadra and Sudarshan into the new body. The new wooden idols of Lord Jagannath, Balabhadra, Goddess Subhadra and Sudarshan are welcomed to the temple with great celebration and it is a great event in the cultural calendar of Odisha and among the Hindus. The new idols are carved and old ones are cremated with rituals mentioned in the century old scripture. This special celebration will be held on **06th July 2016** in the holy city of Puri, Odisha, at the time CAR Festival, **from 05<sup>th</sup> to 14<sup>th</sup> July 2016**. It is hoped that, 20 lakhs of devotees & visitors from all over world will visit Puri, during this holy festival. In Last 16 year ORMAS has been involved in organising Melas for rural producers in PURI during the CAR Festival.

An Exhibition in the most general sense is an organized presentation and display of selection of items. Exhibition/Mela has been part and parcel of entertainment and relaxation activity of our culture; DSMS, PURI has used this medium as a channel to promote rural products made by the Institutions of poor. The experience shows that this has been a very good Platform for business of Rural Products

DSMS, PURI is going to organises National level Exhibition in support of District Administration and collaboration with Odisha Livelihoods Mission (OLM), and other line departments like [DC (Handicraft), KVIC/KVIB, Department of H & CI, TDCC, ORTSS, COIR CORPORATION MVSIN, NABARD, Nationalized Banks, Horticulture deptt. Jail Deptt. Wild Life, Bayanika, DRDA, DSMS, Print media with an objective to provide a platform to the rural producers to showcase their products for direct sale, interact and get taste, choice & preferences of urban consumers. It also helps to the rural entrepreneurs identify livelihood opportunities and establish links with the markets in urban and semi-urban areas.



**B. TERMS & CONDITIONS FOR FOOD STALLS.**

1. **28 Nos. of Stall (Food Stall)** will be available by DSMS, PURI for sales of food items during the National Level Pallishree Mela-2016 **from 05<sup>th</sup> to 14<sup>th</sup> July 2016**. It is the responsibility of the firm to provide hygienic food as per the specification.
2. The deposit amount has to be made by the firms in Shape of demand draft/pay order in favor of DSMS PURI payable at Puri on dated 01.07.2016 at 10.30 A.M. at office of the Chief Executive, DSMS, Puri C/o DRDA, Puri
3. One firm is authorized to bid for one stall only.
4. The bid should accompany with the challan of receipt. The offer price should include all taxes & duties.
5. The bidders are required to deposit an earnest money of Rs. 2,000/- (Rupees two thousand only) in shape of demand draft/pay order in favor of DSMS PURI payable at Puri. The E.M.D. amount of the successful bidder will be kept with DSMS, PURI till the completion of the exhibitions i.e. (National level Pallishree Mela-2016). In case of any unsatisfactory food quality provided during the time of Mela the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
6. The bidders will be used their own Dustbin & take care the cleanness of stall & front area during that time.
7. The rate offered by the firm should be valid till completion of the National level Pallishree Mela-2016 of DSMS PURI.
8. The Tenderers have to offer the minimum **price @ Rs. 15000/- per stall for 10 days only from 5<sup>th</sup> to 14<sup>th</sup> July 2016** as per the prescribed format in Annexure- A otherwise the tender paper will not be considered. Bidder may be quoted the unit price minimum rated higher side perform bidder computation.
9. The rate offered by the firm shall be including of all taxes and duties including Service Tax.
10. In case of same product the comparison will be made as per the highest quotationer price by the bidder.
