- This enquiry is in the nature of quotation call notice intended to hire services of Chartered Accountant firms for special audit of Accounts of Shakti Gaon Project in Ganjam District managed by ORMAS for the FY period 2014-15 to 2017-18
- The Chartered Accountant Firm shall be required to undertake the assignments as mentioned in the Scope of Work.
- The costs of preparing the proposal and of negotiating the contract if any including visits to the Client etc are not reimbursable.
- The Firm shall be deemed to have full knowledge of the role and responsibilities of the work, where works to be carried out.
- The Bidder is expected to carefully examine all the instructions, guidelines, terms and conditions and formats. Failure to furnish all the necessary information as required by the QUOTATION CALL NOTICE or submission of a proposal not substantially responsive to all the requirements of the QUOTATION CALL NOTICE shall be at Bidders own risk and is liable for rejection.
- The proposal and all the associated correspondence shall be written in English and shall conform to the prescribed formats.

10. Submission of Report:

The firm has to Submit the Financial Statement (Balance Sheet and Profit and Loss Accounts including all Schedules and Bank reconciliation) for each year separately in Hard Copy and soft copy to CEO, ORMAS within 16 working days from the date of Acceptance of Work Order.

ORMAS may extend the assignment and its locations for further period depending on the performance of the firm and Timely Completion of work. In addition of the Scope as above the management may change the scope of work during the assignment period considering the requirement in consultation with CA firm.

11. Penalty/ Liquidated Damages:

A default / delay of 10 days from the due date to deliver the outputs specified above shall attract a penalty of 0.5 % of the fees payable for the respective deliveries for the delay. Such a penalty shall be levied after 10 days at 0.05% per week or part thereof up to a maximum of 5 %. If it is observed that the delay is not due attributable to the CA firm, then such a penalty may not be levied.

12. Disqualification:

- ORMAS may at its sole discretion and at any time during the evaluation of the Proposal disqualify any Bidder if the bidder has:
- Misleading or false representations in the forms, statements and attachments submitted as proof of the eligibility requirements
- Exhibited a record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial failures in any of the previous undertakings by the concerned bidder.
- Withdrawal of Proposal by the Bidder after the Proposal Due Date will lead to blacklisting and debarring the bidder in all the future assignments along with forfeiture of the EMD.
- Declared as ineligible by GoI / State / UT for corrupt, fraudulent practices or has been blacklisted.
- A Bidder's proposal may be rejected if it is determined that the Bidder

- has engaged in corrupt, fraudulent or unfair trade practices.
- The firm proposes any alteration in the work specified or any conditions or corrections made in this Bid.
- The firm shall submit the Bid which does not satisfy each and every condition laid down in the notice, failing which the Bid will be liable for rejection.
- Firm's Bid containing conditions shall be liable for rejection out rightly without assigning any reason for the same.
- Stipulates the bid validity period less than what is stated in the form or tender.
- Stipulates its own conditions.

13. Conflict of Interest:

The Chartered Accountant Firm at all times shall hold the ORMAS's interest paramount and shall avoid conflicts with its other assignments.

14. Right to Accept or Reject Proposals:

ORMAS reserves the right to annul the QUOTATION CALL NOTICE process, or to accept or reject any proposal, in whole or part without assigning reasons and without any obligation to inform and without incurring any liability to any of the bidders.

15. Validity of Bid:

The Bid submitted by the bidders shall remain valid for a period of **90 days** from the technical bid opening date.

16. Submission of Proposal:

A bidder is allowed to quote only one quote for the selection process. CA Firm is required to offer the rates in lump sum for the activities to be undertaken as mentioned in the Scope of Work of this QUOTATION CALL NOTICE and taxes and duties for the assignment to be stated separately.

- The bidders are requested to submit their financial proposal as per the prescribed format. Any deviation to the prescribed format for submission,

20. General Terms and Conditions

- ORMAS reserves the right to extend the period of audit at the same prices, terms and conditions.
- ORMAS or Authority Designated in this behalf reserves exclusive rights to modify/ increase scope of the selected firm and will be informed accordingly to the selected firm.
- Expenses for the work: All insurance shall be taken out by the firm from material damage and any mishaps and lapses.
- The Bidder shall not assign the project to any other agency, in whole or in part, to perform its obligation under the work, without the ORMAS's authorized representative's prior written consent. Sub-contracting of the services allotted ***is not allowed in any manner.***
