### Scope of Work

### i) Videography:

- The entire event will be video documented in Digital High-Definition Video (HDV)
   Camera.
- A small documentary film/movie of mela with minimum 10 minutes duration should be made. The documentation to cover like: Inaugural & Validation function, Gate & Stage, Mela Advertising & Publicity Workshops, Interaction with customers/sellers/ officials, Cultural Programmes, Success Stories, etc. This should be done with video editing, applying special effects, music, voice over and necessary sound editing. The time of the movie may be more depending the days of the mela & decision of the organizer.
- State/District wise videography along with success stories, interaction with visitors/sellers etc.
- Necessary actions should be taken during final post production and final preview of the documentary in consultation with ORMAS, DEOGARH.
- The documentary film of the mela should be submitted in ORMAS, DEOGARH office within 05 days of the completion of the event on proper receipt in 3 copies DVD format.

#### ii) Still Photography:

- The still photographs (maximum of 100 Pcs.) as required by the mela authority. The still photographs should cover all aspects of Inaugural & Validation function, Gate & Stage, Mela Advertising & Publicity Workshops, Interaction with customers/sellers/ officials, Product Photographs, Cultural Programs, live demonstration, Success Stories, etc 2 sets of still photos in mat paper of 4" X 6" size in an album with digital copy should be submitted in DSMS DEOGARH office within 05 days of the completion of the event.
- State/District wise photography along with success stories, interaction with visitors/sellers etc.
- iii) LCD Display: Four LCD display has to be setup in four locations in the mela ground. More numbers may be put in the Mela ground with the approval of the concerned mela authority.
- CCTV:Eight (08) numbers of CCTV to be installed in the complete mela ground to keep a
  watch on the visitors & the participants. The numbers may vary depending on the
  requirement and decision of the mela authority.

#### A. Terms and Conditions

- 1. The work assigned to the firm should be done as per the above specification and should cover all aspects of the exhibition.
- 2. The period of exhibition will be 05 days.
- 3. The work should be completed within the time frame.
- 4. Sanctions of any advance will not be considered. The payment will be made on completion of event.

- 5. The price offered by the firm should include all taxes. However the **GST** will be deducted from the bill amount and deposited with the concerned authority if applicable.
- 6. The rate offered by the firm shall be including of all taxes and duties.
- 7. The same rate may kindly be considered If the district administration extended 1 or 2 days Pallishree Mela -2022 extra charges not applicable in any circumstances.
- 8. The above documented works should be submitted within 05 days of the completion of the exhibition.
- 9. The tenderers are required to deposit an earnest money of Rs. 5000/- (Rupees five Thousand only) in shape of demand draft/pay order in favor of DSMS DEOGARH payable at DEOGARH. The E.M.D. amount of the successful bidder will be kept with DSMS DEOGARH till the completion of the exhibitions (i.e. for a period 27th April to May 1st 2022). In case of any unsatisfactory work, delay in execution of work etc. the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
- 10. The tenderers have to offer the price for all items else the tender paper will not be considered.
- 11. The rate offered by the firm should be valid till completion of the State Level Pallishree Mela-2022 at Deogarh.
- 12. The rate offered by the firm shall be including of all taxes under GST and duties. The Bidder has quoted their best price for all items maximum total amount up to Rs. 40,000/- (fourty thousand) only.
